#### 6. Engagement mechanism with industry

- All responsible entities as mentioned in s.no 5 above will work towards having a formal engagement agreement with industry in their respective domains.
- An annual engagement calendar will be prepared by responsible entities and circulated to relevant stakeholders for their information.
- Industrial visits to be organized for students of each academic program in their area of study.
- Career fair will be an annual event and shall try to attract potential recruiters in the college campus.
- Feedback from industry experts is to be taken on graduates, graduate attributes, programs and curriculum for making necessary improvements tailored to the needs of industry.
- ZCW will strive to conduct sufficient number of guest lectures / workshops by industry experts for enhancing the learning experience of students.
- Students will be provided with training and internship opportunities in accordance to the study requirements
- Academic staff will contribute their expertise to relevant partners in industry.
- Feedback has to be taken from all participants on different aspects of engagement.
- Feedback needs to be analyzed and steps be initiated for necessary improvements by concerned entities.

#### 7. Approving Body

This policy shall be approved by the Board of Trustee (BoT).



### 8. Breach of Policy

- Any breach of this policy should be given in writing to the Dean.
- If the Dean is satisfied, a committee will be constituted to investigate the matter and submit its report and recommendations.
- Penalty for the breach will be imposed on the concerned stakeholder as per recommendation of the committee and in accordance to rules and regulations of ZCW.
